Chief Jimenez reviewed the February monthly Police Department activity report. A total of 166 calls were received during February. The officers covered 1956 miles patrolling the town. Chief Jimenez also spoke about his new car which is a 2020 model and not a 2019 as was ordered but was sold to the City for the same price.

Matthew Carpenter from AW Broadband provided an overview of services that his company could provide to the City of Friona as they continue their service into New Mexico.

MOTION Alderman Lewellen made the motion to approve the lease agreement between the City of Friona and AW Broadband to lease building and tower space located near West 15th Street and James Avenue in Friona. Alderman Stowers made the second to the motion and the motion passed with a 5-1 vote with Alderman Loflin voting no.

City Manager Davila reviewed Accounts Payable with the City Council.
