On August 10th 1949, Nelson and Lorraine Welch granted the city of Friona a 30 ft. easement of the Welch subdivision of "acreage tracts 9 & 10". On November 5th, 2013 the city asked for an additional 10 feet easement to lay a water line along tract 9 & 10 turning North onto CR 19 (cemetery road).

Antonio Monreal is asking to encroach on the city's easement by 20 feet to build a fence. If his request were to be granted, he has stated that he would allow the City of Friona full access to enter the property in the event there are any issues with the water line.

City council members unanimously agreed to table Item 12 until they can consult with city attorney.
