## ITEM 2 CONSIDER AND TAKE ACTION ON APPROVAL OF MINUTES OF THE MARCH 22, 2021 PLANNING AND ZONING COMMISSION

# ITEM 4 AN ORDINANCE AMENDING THE FRIONA CODE OF ORDINANCES, CHAPTER 4, "BUSINESSES REGULATIONS", BY ADDING ARTICLE 4.400 "MOBILE VENDORS" TO ALLOW FOR AND REGULATE MOBILE VENDORS; REQUIRING A PERMIT; ESTABLISHING A FEE; REQUIREMENTS, AND HOURS OF OPERATION; PROVIDING A PENALTY; PROVIDING AN EFFECTIVE FATE; PROVIDING A REPEALER; AND PROVIDING FOR PUBLICATION; AND PROVIDING FOR PUBLICATION

City Manager Davila briefed the commission of the ordinance that was included in the packet and informed them that the City's attorney drafted 2 separate ordinances instead. City Manager Davila provided the commission with the new ordinances and asked to postpone this item with the new ones for next week's meeting. Carroll Cook made the motion to postpone this item to include the new ordinance for next week's agenda. Mayra Olmos second the motion and the motion passed with a vote of 5/0.

## ITEM 5 DISCUSSION REGADING A RENTER'S ORDINANCE TO ALLOW FOR AND REGULATE OWNERS OF SINGLE-FAMILY, DUPLEX AND MULTI-FAMILY RESIDENTIAL RENTAL PROPERTIES

City Manager Davila briefed the commission of the Friona City Council's intension of having the commission draft a renter ordinance to allow for and regulate owners of single-family, duplex and multi-family residential rental properties in Friona. He also stated that the City's attorney wanted to speak to the commission at their meeting next week in person about this ordinance and this past experience with other communities who have chosen to implement a rental property ordinance.
