**WHEREAS,** the City Council of the City of Friona desires to develop a viable community, including decent housing and a suitable living environment and expanding economic opportunities, principally for persons of low/moderate income; and

WHEREAS, certain conditions exist which represent a threat to the public health and safety; and

**WHEREAS**, it is necessary and in the best interests of the City of Friona to apply for funding under the Texas Community Development Block Grant Program;

### NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF FRIONA, TEXAS:

- 1. That a Texas Community Development Program application for the <u>Fire</u>, <u>Ambulance</u>, and <u>Service Truck (FAST) Fund</u> is hereby authorized to be filed on behalf of the City with the Texas Department of Agriculture.
- 2. That the City's application be placed in competition for funding under the <u>Fire, Ambulance, and Service Truck (FAST) Fund</u>.
- 3. That the application be up to \$750,000.00 of grant funds to purchase fire truck(s).
- 4. That the City Council directs and designates <u>the City Manager</u> as the City's Chief Executive Officer and Authorized Representative to act in all matters in connection with this application and the City's participation in the Texas Community Development Program.
  - The Mayor and City Manager shall serve as the City's Chief Executive Officer and Authorized Representative to execute this application and any subsequent contractual documents;
  - The Mayor and City Manager is authorized to execute environmental review documents between the Texas Department of Agriculture and the City of Friona; and
  - If this application is funded, the Mayor, City Manager and City Secretary is authorized to execute the Request for Payment Form documents and/or other forms required for requesting funds to reimburse project costs.
- 5. That all funds will be used in accordance with all applicable federal, state, local and programmatic requirements including but not limited to procurement, environmental review, labor standards, real property acquisition, and civil rights requirements.
- 6. That it further be stated that the City of Friona is committing  $\frac{49,500}{500}$  from its <u>General Fund</u> as a cash contribution toward the construction and administration activities of this fire truck(s) project.
