<u>Section 2</u>. In accordance with Section 32.091 of the Texas Election Code, the judges shall be paid at the rate of \$12.00 per hour. The election clerks shall be paid at the rate of \$10.00 per hour.

<u>Section 3</u>. Rosa Mendez, City Secretary, will serve as election clerk for the early voting to be held at the City Council Chambers located at 619 Main Street, Friona, Texas.

<u>Section 4</u>. Early voting, both by personal appearance and by mail shall be by paper ballots and shall be canvassed by an Early Voting Ballot Board.
