ITEM 3 CONSIDER AND TAKE ACTION ON APPROVAL OF THE FRIONA ECONOMIC DEVELOPMENT CORPORATION MINUTES OF APRIL 3RD, 2023

Greg Lewellen made the motion to accept the minutes of the April 3rd, 2023 Friona Economic Development Corporation. The second to the motion was made by Holly Campbell and the motion passed with the unanimous vote of the FEDC Board of Directors.

ITEM 4 CONSIDER AND TAKE ACTION ON APPROVAL OF STOREFRONT GRANTS FOR PAM'S KITCHEN, CHUCK'S BARBER SHOP, GEMS SALON, DALE HART RENTALS, PARMER COUNTY MUSEUM AND A-1 SERVICE CENTER

The motion was made by Henry Clark to approve the storefront grants for Pam's Kitchen, Chuck's Barber Shop, Gem's Salon, Dale Hart Rentals, Parmer County Museum and A-1 Service Center. The second to the motion was made by Andy Alexander and the motion passed with the unanimous approval of the FEDC Board of Directors.

ITEM 5 CONSIDER AND TAKE ACTION ON REQUEST FOR FINANCIAL ASSISTANCE FROM HAPPY TRIBE ACADEMY FOR DAY CARE STARTUP COST

Mariza Licerio is requesting a grant from FEDC in the amount of \$37,581.00 for day care start up cost. The board agreed that they will have a 60-day waiting period after opening day of the center to cut the check for the requested amount. The day care is scheduled to open in September 2023.

Greg Lewellen made the motion to approve the request for financial assistance from Happy Tribe Academy for daycare startup cost. The second to the motion was made by Clint Mears and the motion passed with the unanimous vote of the FEDC Board of Directors.

ITEM 6 DISCUSS AND TAKE ACTION ON FUNDING OF ECONOMIC DEVELOPMENT PROJECT BY THE FRIONA FEDC FOR BUSINESSES THAT RESIDE IN THE HALF MILE EXTRA TERRITORIAL JURISDICTION OF THE CITY LIMITS OF FRIONA

Franklin Baker is seeking financial help to purchase appliances that are needed for a restaurant he is opening at 1505 W. 5th Friona, TX. This address is located outside city limits. The board unanimously agreed that he should be a member before he receives financial assistance.

Andy Alexander made the motion to fund an economic development project by the FEDC for a business that resides in the half mile extra territorial jurisdiction of the city limits of Friona. The second to the motion was made by Greg Lewellen and the motion passed with the unanimous vote of the FEDC Board of Directors. Justin Jeter made the suggestion for financial help to purchase supplies for Mr. Baker in the form of a forgivable 12-month loan at 0% interest, with Mr. Baker becoming a chamber member immediately. Holly Campbell agreed with this suggestion.
